Developments in Sanofi: alarming signals in the industry

reorienting in operation the Sanofi country, management has continued to retrench its field workers in almost every division. All those products that brought hefty profits to the coffers of the company over the years are now being given on marketing leases to Indian monopoly houses for a fixed period of time. It first started with selling its Nutraceutical business to a newly formed company called Universal Nutrisciences at the end of 2021. Prior to that, the vaccine business that was carried out by Sanofi Pasteur, was given be marketed by IQvia. which was a consultation company that turned its eyes towards pharma business. Towards the end of 2023, the management also announced the business being carried out by the Mass Therapy division will be demerged from Sanofi India to form a new entity called the Sanofi Consumer Health Care

Ltd. and a section of

company. Recently the management decided to lease the cardio vascular products to M/S Emcure and in the process compelled all SPEs working in the company to move to Emcure with fresh appointment letters with derogatory service conditions. 11 unionised field workers who refused to accept such illegal offers were summarily terminated from their jobs at the middle of night.

What is remarkable is that in all the above steps where there has been termination of the SPEs, there is also total reversal of the existing conditions the unionized employees marked by totally new operational environments. In the first instance all the unionized SPEs, 54 in total that refused to accept the reversed service condition in the new company were summarily terminated. In spite of repeated persuasions and industrial actions by HAIRC, of which these were members. managements refused to withdraw the terminations. The SPEs who fought for a long time to establish

their bargaining status within the company were once again de categorised to non cadre in bargainable the new company. In the recent instance, the SPEs working in the Cardio Vascular division were forced to resign from the company, then given fresh appointment letter by Emcure with six months' probation. Such derogatory and outrageous offers have become the hallmark of all recent business dealings of Sanofi. They snatching awav the existing rights of their field workers and forcing them to work for generating profits other companies where the products they promote are either sold or leased.

While **HAIRC** has given call for all out struggle to protect their members FMRAI has also come forward to support the field workers in Sanofi throughout the country. It is important to understand that developments the in Sanofi are not to be seen in isolation. It is to be viewed in the larger canvas of the MNCs aggressively

restructuring process in India and in the course. trample the legal, trade union and collective bargaining rights of the workers. The plan is to bring very high priced patented products in the Indian market and resort to extreme niche marketing with the help of digital technology thereby making the existing format of sales promotion by the SPEs redundant.

therefore important understand that to stop the initiation of the complete change in the current format of sales promotion, the field workers of all corners and of all companies must realize and gear up to resist such nefarious plans by the MNCs. If they succeed, within no time, the virus is likely to spread over the entire industry causing serious and widespread victimisations of the existing field workers. FMRAI will support and actively engage in all struggles to resist such attempts, and calls upon all field workers involve them in struggle to save the union within the industry.

EDITORIAL

Reclaim the workplaceidentify the enemy

On the 19th of April, 2024 a very disturbing news came out from the national capital which casts a deep shadow on the present condition and the future of hundreds of thousands of Sales promotion Employees working in the Pharma Industry in India. It is now well known to all that The BJP government is quite prompt in arresting all adversaries through various agencies at their disposal like the Police, CBI and ED. Whether they are political adversaries or the section of the working class that have been consistent in raising its voice against the misrule of the government, all have been at the receiving end of their ire. The Sales Promotion Employees under the guidance of FMRAI have been in the forefront of agitation against the anti-worker steps of the Modi Government. Since the Modi Govt came to power, obstacles were created in various central hospital and clinics on visits of the Medical Representatives to the doctors. Following the central government, various states like UP also attempted to restrict the work of MRs in their hospitals. News have been pouring in about the unofficial restrictions of sales promotion works in various prestigious central hospitals in Delhi for quite some time. Hospitals AIIMS, Safdarjung Hospital and Ram Manohar Lohia hospital authorities banned the visits of the MRs without any official notice. The SPEs were harassed by Delhi police which works under the Central Government, and the security personnel from time to time. In AIIMS the authorities even refused to meet a delegation of FMRAI intended to sort out the issue. In spite of repeated efforts by FMRAI and DSMRO, the permission to visit the OPDs to allow the SPEs to do their

legitimate work was not allowed. On 12th May, 2023, the CGHS issued a circular "instructing total curtailment of entry/work of the Medical Representatives in all establishments of the CGHS". FMRAI promptly challenged this draconian decision of the government through its letter addressed to the DGHS where the entitlement to visit a doctor in the hospital as mentioned in The Sales promotion Employees Act, 1976 and GSR 843 of the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954. The letter also mentioned that the central government has constituted a National Tripartite Committee for the Sales Promotion Employees of which FMRAI is a member. That was followed by the same letter being sent by all

states to the DGHS. Unfortunately, there was no change in the stand of the DGHS and restrictions to visits continued. This finally culminated in the ghastly incidence of arrest by Delhi police, on 19th April, of the SPEs in the Safdarjung hospital. Reason, they just wanted to do their lawful job in the OPD!

This villainization promotion Employees without any valid explanation reflects the general attitude of an intolerant Government having scant respect for the law of the land. Further the employers as usual has been totally silent on the issue. In no other sector possibly the regular harassments of the employees are met with such deafening silence by the employers whose work the SPEs are supposed to do in the OPDs. As if the troubles, whatever arise, are to be settled by the SPEs themselves and ensure the required number of calls per day and deliver to the employers, come hell or high water!

The denial of calling a meeting of the Tripartite Committee by the Government and denial of forming any Statutory Working Rule are reasons that the agencies of the same government can impose such ruthless embargo and unleash the Police at their will branding the medical representatives as offenders. On the other hand, the employers, while carefully distancing them from these incidences, will impose their private working rules ignoring the realities of the field and castigate the SPEs and harass them for not achieving the desired call objectives.

As such the future of physical sales promotion is under threat after the pandemic because of adoption of digital channels of sales promotion to the doctors by various companies. While there is no provision in the law that authorizes a pharma company to promote their products through non-human methods, bigger pharma companies especially the MNCs have resorted to digital meetings, social media, zoom and other internet based social chatting and meeting platforms for contacting doctors. Unlawful as this is, the government instead of taking steps against these activities, are actually creating hindrances on the legally authorized channel of pharma promotion, i.e. through the "medical detailers" as identified in the law. It is imperative for the field workers of the country to understand the conspiracy and identify their real enemy in the country and change for their own good.



Legal entitlements for sales promotion work

Medical Representatives, legally known Promotion Sales **Employees** working in the Government Central hospitals and other establishments in peaceful and disciplined manner for decades with utmost care for ailing patients in these institutions. The Medical Representatives their legal recognition through enactment of The Sales Promotion Employees (Conditions of Services) Act, 1976, which defines Sales Promotion Employees as "..... means any person by whatever name called (including an apprentice) employed or engaged in any establishment for hire or reward to do any work relating to promotion of sales or business, or both,

Further, Section 2(a) of the said act also defines establishment as "means an establishment engaged in pharmaceutical in any industry industry' notified Therefore. as you understand, these workers are permitted by law to perform the job of Sales Promotion the products pharmaceutical the Industry i.e. medicines and medical devices, to the Doctors and that is their primary job responsibility.

The entry of the Sales Promotion Employees into the places where Doctors also perform their duties is recognized by the Government as "Medical Detailers" as per Magic Remedies and Objectionable Advertisements Act, 1954 through a General Statutory Rule (GSR 843) dated 29th May in the year 1967

vear 1967. The above provision clearly savs the prohibition advertisement of certain drugs for treatment of certain diseases disorders (as mentioned in Section 3 of the said Act) is not applicable to Medical Literature distributed by "medical appointed detailers manufacturers, importers or distributors of drugs, duly licensed under the Drugs and Cosmetics Act, 1940 (23 of 1940) and the Rules thereunder". This was done after section 15 of the said Act directed the Government to specify allowing advertisements of drugs in interest". The "public lawful recognition of Medical Representatives to meet the Doctors in their work places is clearly entailed in the above statutory provisions.

Central The Government has also constituted an Industrial Tripartite Committee for the Sales Promotion Employees to look into various aspects of these workers giving due recognition and credence to this occupation and our organisation FMRAI is one of the constituent of the same.

Developments in Micro Labs management of tagging of the Doctors through which is clearly against the law remove this illegal g

management ■ he has M/sMicro Labs unilaterally brought in their change reporting Navdisha. system The management is creating unjust pressure and is also threatening the SPEs of Micro to download the changed Navdisha app in their personal mobile thereby changing the reporting system from web based to mobile app based mode. Furthermore the management has unilaterally and illegally initiated the geotagging of the Doctors through the newly designed App. The Navdisha App clearly declares that it will track the movement and work of the sales promotion employees of the company. The management has threatened to penalize the field workers if they do not carry out the tagging of the doctors in the new App and has also stated that the salary and expenses of the field workers will be withheld if they do not carry out this geo-tagging process,

of the land.

This is a clear violation of the established work norms and is a violation of Sec 9 (a) of the Industrial Dispute Act of 1947. This tracking and surveillance of the sales promotion employees is a clear violation of law, violating the privacy of an individual employee (refer to the judgement of K.S. Puttaswamy Vs Union of India on 26th of Jan 2018). FMRAI has urged the Micro management to

remove this illegal geo tagging of doctors in the new App, and restore the web based Navdisha reporting portal to restore normalcv in the working condition of the SPEs of Micro Labs. Closely watching over the developments, FMRAI will be compelled to raise the issue in appropriate forums and also undertake suitable industrial actions against Micro management if the unilateral tracking through geo-tagging is not withdrawn.

We note with serious concern that anti people and pro corporate approach on the part of Union Government is taking its toll on the accessibility to healthcare by the common people of the country. The recent media publication of huge donation of money to political parties through electoral bonds by the pharmaceutical companies and various groups of corporate hospitals clearly indicates the nexus between the pharma corporates and the Government. Surprisingly the observation of the drugs control organization offices on poor quality of drug in the market has been ignored. The Union Government instead of initiating stringent action remained silent onlookers compromising the health of the people of the country. Moreover taking into consideration the current socio-economic situation of the country where huge number of the population is struggling to meet their daily nutritional needs, the Union Government is ensuring hefty profit to the pharma companies (by diluting price control on medicines) and by imposing GST @5%, 12% and 18% on medicines (thereby) literally robbing the common people.

Therefore we urge upon the Union Government to take urgent action on the following demands placed by the Federation of Medical and Sales Representatives' Associations of India (FMRAI) and its affiliated state units to your good office to provide improved accessibility of health care and medicine to the common people:

1) Zero GST on Medicines and Medical Devices.

- 2) Take effective steps to reduce medicine prices in the country and stop increase in the prices under the national List of essential Medicines
 - 3) Allocate of 5% of GDP to healthcare for the people of India
- 4) Revive the public sector drug units including vaccine producing units to provide quality medicines at affordable prices.
- 5) Ensure Production of Active Pharmaceutical Ingredients (API) in India to avoid dependence on foreign countries
- 6) Impose a cap on all drug prices; fix the prices of all essential drugs at the minimum possible; revert to cost based system of price control; stop legitimizing the present market based pricing system
- 7) Ensure the availability of all essential drugs through enforcing compulsory licensing mechanism. Stop attempt of dilution of Indian Patents
- 8) Stop online sales of medicines. This practice is contrary to Drugs and Cosmetics Act and is susceptible to misuse. The prospect of promotion of irrational and non-essential medicines through online pharmacy is threat to public health.
- 9) Withdraw the decision of NPPA to increase the price of more than 800 drugs. Stop linkage of prices of essential drugs with Wholesale Price Index

As a citizen of the country I support the above demands and urge upon the Union Government to adopt policies in line with the demands to provide relief to the ailing people of the country.

Students reject the communal politics premier university of the Parishad (ABVP)

coalition of Left nt parties, Left IIswept the student union elections at Jawaharlal Nehru University (JNU). winning all four central panel seats on offer president, vice president, general secretary, and joint secretary. The JNU student union (JNUSU) elections were held on Friday but the results were declared on Sunday. These were the first student body elections held at the university since 2019, following a four- year break brought on by the pandemic. For elections, student organisations such as the All India Students' Association (AISA). Students Democratic Federation (DSF). Federation Students' of India (SFI), and the India Students' Federation (AISF) formed a united Left front, facing off against the Rashtriya Swavamsevak Sangh (RSS) student outfit Akhil Bharatiya Vidyarthi

Dhananjay (goes by single name) from the Left was elected president, defeating ABVP's Umesh Chandra Ajmeera 922 votes. The JNU has been a stronghold of the progressive Left student unions over the years. However, the RSS led BJP through its student wing- ABVP was eveing to capture and dominate the JNU student wing, to destroy the progressive, leaning ideology which always pursued that Nation should arrange for education for all section including the economically weaker section of people. On the contrary the objective of ABVP is to curtail the right of education for weaker section under the disguise of aggressive based Hinduvta caste based politics. hidden agenda was to ensure entry of corporates in the premier educational institution. In desperation of capturing the student's union of the

country, the ABVP went furthest extent the by influencing the JNU authorities to cancel the candidature of Swati Sing. the left candidate for the post of General Secretary the last moment. The students didn't get frustrated, rather got rejuvenated and decided support another candidate unitedly who won by thumping majority. The election was held after a four-year hiatus – initially due to the pandemic and later due to PhD admissions. Around 5,600 students voted this vear, many of whom were first-time voters. Amid the media campaign of single party majority of the Modi government, this comes as a backlash, breaking the myths created by the godi media. The mandate is in favour of inclusive politics, academic freedom and social justice- the core principles that have long being championed by the left leaning student organization at JNU.

People's money in electoral bond

government spent Rs 14 crore of tax payers' money, on printing and managing electoral bonds according data revealed response to a Right to Information (RTI) query filed by a transparency activist Retd. Commodore Lokesh Batra. Out of the total, Rs 12,0459,043 has been charged the 'commission for sale of electoral bonds over 30 phases while Rs 1,93,73,604 account for the printing costs of the bonds. The commission amount refers to the money charged by State Bank of India to sell and manage the electoral bonds. An additional Rs 6,720 has been levied for 'device to verify Mask-A print security', the Department of Economic **Affairs** reported RTIresponse said. Nashik-based India Security Press, tasked printing these bonds. also revealed denomination-wise breakup for printing bonds worth Rs 1,000, Rs, 10,000, Rs 1 lakh, Rs 10 lakh and Rs 1crore. It may be noted that the cost of printing and managing these bonds is not borne by the donors or the recipients but by the government and, by extension, the taxpayers. The irony of the EB scheme is that while donors who buy bond are not required to pay any service charges (commission) to SBI and even printing cost of EBs, it is the government or ultimately, the tax-payers who bear this cost... for enabling transactions of 'anonymous tax-free

opaque Electoral Bonds Scheme 2018, "In addition, there is a huge amount being spent on the use of government machinery manpower managing and operating EB scheme for the taxfree benefits of political parties at the tax-payers cost. The Narendra Modi government printed 8350 electoral bonds of Rs 1 crore eaCHE IN 2024 alone after the Supreme already had reserved its verdict on the constitutionality of the scheme in November 2023. The cost of printing one electoral bond comes to Rs 25, with an additional 6% GST charged both by the Centre and the governments, The Wire had reported. The Supreme Court on February 15 had struck down the electoral bonds scheme. While calling it unconstitutional and in violation of the voters' right to this information, the court had directed the SBI to furnish the details of the bonds to the EC. As the nation's 960 million voters gear up for a crucial national election, the revelations deepened fears that the electoral bond mechanism enabled quid-pro-quo between companies and political parties, creating a stink of extortion and corruption. All of the top 10 corporate donors – from pharma to construction companies – who were being probed the central enforcement agencies in the last five years, paid the BJP in some measure, accumulating over billion rupees (\$15.5m), the dataset revealed.

British **Biologicals field** workers fight back

his notorious management once again terrorizing field workers to accept Geo-fencing and Geotagging reporting through system the CBO reporting app with sole intention to bring their field workers under tracking and surveillance. It is important to mention that existing laws of our country do not allow any company to track any individuals. In order to implement such illegal system of reporting, the management even threatened for of pay", Mana initially faced Management strong resistance from good number of SPEs across the country and withdrew the real time reporting. It is necessary to mention that field workers protesting such against illegal surveillance had been deprived of salary and expenses for 2 months. This year the notorious management is again trying to mount pressure heavily the field workers, but spirited SPEs of British Biologicals are fighting hard to defend their ground. FMRAI, rising up to the occasion initiated country wide protest demonstration in the field. A protest letter was sent to the management asking to withdraw such illegal system with immediate effect, the same is being handed over to the executives during protest demonstration One round demonstration was also staged before the company establishment in the last month.

Khandelwal fieldworkers in protest path

t was noticed that Khandelwal management since the Covid-19 period has been pressurizing and terrorizing the SPEs ground. sales The SPEs are threatened to achieve the sales target, otherwise they would be transferred. Management has transferred the service of one of the Negotiating Committee member. Bhoopinder Singh, from Varanasi to Sharanpur citing poor performance, violating the provisions of law and not following rules of natural justice. During this period the management has also transferred Wahid Khan from Balaghat,

MP to Ambala, Punjab on sales ground. The Khandelwal fieldworkers through the all India Committee demanded immediate revocation of the transfer orders. But the management instead of bilateral discussion is adopting a rigid stand and is not ready to discuss the transfer issues.

The management held a Negotiating Committee meeting few months back but were reluctant to discuss and settle the submitted Charter Demands. Also violating the Memorandum the Understanding, management has been continuously imposing newer work systems.

The in the company highly agitated as management is tactically trying to snatch away the rights achieved by the SPEs, ignoring the bilateralism and changing their service and working conditions unlawfully Accordingly Khandelwal fieldworkers sent protest messages to the management on 22nd April. 2024 demanding revocation of all malafide orders transfer settlement of pending Charter of Demand. The protest programmes shall intensify until the justified demands of the fieldworkers gets resolved.

In India in the midst of the General Election this May Day bears immense significance. The working class of India, protecting its basic rights including the right to 8 hour work, requires the decisive defeat of the NDA alliance representing the corporate communal nexus. The ten years of BJP rule seen relentless attacks on the lives and livelihoods of all sections of the toiling people of our country. Through its persistent united struggles, the working class of India has been able to stall notification of the disastrous labour codes. Now is the time to ensure these are scrapped through stronger united struggles. The defeat of the ruling party at the centre is not only necessary for the scrapping of the codes but also is a prerequisite for strengthening united struggles against the neoliberal disastrous policies which are totally against the interests of the workers, peasant, all sections of the toiling people and the nation as a whole. India is among the most unequal societies in the world. The entire economy employment relations industrial processes are being restructured establish absolute control over all national assets and natural resources infrastructure economic management by a handful monopoly companies. authoritarian centralized management of the economy is also reflected in the aggressive attacks on democratic processes and institutions to facilitate such loot and plunder. 
