Purchasing this spacious apartment property of three rooms along with other necessary facilities at prime location of Daryaganj is aimed to fulfil the purpose of FMRAI's movement and organisation. Delhi has been the centre of activities related to follow up with Central Government on various issues of the sales promotion employees. Thus this new building will be the pivotal centre through which necessary activities shall be performed in days to come. It was planned in advance to inaugurate the new building and the inauguration ceremony of the building was held on 26th August, 2022. This new building of FMRAI has been named as "Comrade D P Dubey Memorial Education Centre" and nothing would have been more appropriate to exhibit respect to the legendary leader popularly called as Dubeyda by the members of FMRAI throughout the country. Six years back, on 26th of August, 2016, we lost Comrade D P Dubey, the longest serving General Secretary of FMRAI. He was elected as General Secretary in Chennai Conference of FMRAI in 1991 and continued to work devoting his entire wisdom, energy and intellect up to the Golden Jubilee Conference held in Kolkata in 2013. Comrade D P Dubey was a leader with difference, because of infinite reasons. He was loved and accepted by all the members of the organization. His amiable personality, typical mixing style with members, remembering large number of members by names and besides all, defending the members against attack of the employers was instrumental in

Industrial actions continue against mass victimization



Demonstration against Pfizer in Mumbai

A week long relay demonstration programs was organised in the month of August, 2022 against 5 identified companies Albert David, TTK, Pfizer, Himalaya Wellnessand AFD in continuity to the Anti Victimisaton Day programme. The turnout of the members in these demonstration programme in front of company's establishments all over the country exhibited their hatred to the policies adopted by these employers in flagrant violation of the laws. After spontaneous program participation of Anti Victimization Day of last month, FMRAI continued the wave of protest for those 5 companies. Under the shadow of pandemic situation all multi-national companies were downsizing field workers to ensure there profit margin, though pharmaceutical Industry was not effected due to lockdown in terms of business. The victimization took place inorganised councils where bilateralism continued or grievance committee existed for a long time under the banner of FMRAI. The main intention of the employers is to dismantle the

business". From 8th August to 13th August, 2022 most of the state units arranged successful demonstration programme in front of establishments of the five identified companies. BSSRU state unit organised in their state capital at Patna and every day large number of field workers participated in those activities. During gate meetings members protested by slogan shouting against the atrocities of the managements. Vice President and General Secretary of BSSRU State addressed to all participants about present situation of victimized members of this companies and the leadership of the Patna unit also expressed their views regarding the present situation. TMSRU State unit arranged programmes in Hyderabad and during demonstration program of AFD and Himalaya they submitted memorandum to management. WBMSRU started massive campaign among the members against those 5 identified companies and implemented demonstration programmes successfully in two subunits

Editorial

Recall the sacrifices and fight back

The country went on to celebrate the 75th anniversary of independence in a big way; "Hereber Tironer" has been also "HargharTiranga" has been the theme asking all Indians to hoist the national flag in every home of India. Yet the working people of the country face almost insurmountable obstacles that pose challenge to the basic significance of the struggle that freed 36.1 crore Indians from the rule of foreign empire. The economic drainage that took place under the British rule was supposed to be overturned, all people of India were supposed to equal in terms of their accessibilities of the resources. people were to have jobs, incomes, rights towards health and education. Those were the dreams of our freedom fighters. It was Bhagat Singh who said, "Producers or labourers in spite of being the most necessary element of society are robbed by their exploiters of the fruits of their labour and deprived of their elementary rights. The peasant, who grows corn for all, starves with his family, the weaver who supplies the world market with textile fabrics, has not enough to cover his own and his children's bodies, masons, smiths and carpenters, who raise magnificent palaces, live like pariahs in the slums. The capitalists and exploiters, the parasites of society, squander millions on their whims (from the text of Bhagat Singh and B K Dutt's statement, read in the court by Asaf Ali on June 6, 1929) B. R. Ambedkar in his famous speech in the Bombay Assembly against the Industrial Disputes Bill which sought to curtail workers' right to strike and form independent union said, "a democracy which

enslaves the working class, a class which is devoid of education, which is devoid of the means of life, which is devoid of any power of organisation, which is devoid of intelligence, I submit, is no democracy but a mockery of democracy

"If members are prepared to accept my meaning of the word "strike" as being nothing more than a breach of contract, then I submit that a strike is simply another name for the right to freedom."

It is precisely those demons against which men like Bhagat Singh and Ambedkar warned, that have returned to haunt us as we the people of India who gave ourselves constitution, are busy celebrating our Independence for the 76th time. Unemployment has reached almost monstrous proportions. According to the Centre for Monitoring of Indian Economy (CMIE), unemployment rate as on 29th of August was 8.3%, out of which the urban unemployment rate reached 9.6%. Among the states, states like Bihar, Haryana, Jharkhand, J&K, Tripura and Rajasthan all touched double digit unemployment rate.

A recent study conducted jointly by Centre for Science and Environment and the journal Down to Earth reveals that 71% of Indians cannot afford two healthy meals per This results in numerous deaths and health related diseases every year. The study named as State of india's Environment, 2022 points out that the prices of food is on an average 63% more than the daily income of majority of Indians. According to Down to Earth the prices of fruits and vegetables have seen hikes to the extent of 84%, making them unaffordable for the majority Indians.

In the health and hygiene front that inevitably impacts the productivity of the working class of the country, the picture is equally dismal. India is home to an enormous number of malnourished people of the world, with 14% of our people being malnourished, 20% of children are underweight and more than 50% women of reproductive age being anaemic.

While the ruling class has designed various methods including the concoction communalism and pro rich policies to divert any expression of dissent among the people, the government has dedicated itself to dilute the power of the workers of the country through decimation of their rights. It is true that for any ruler eager to please the rich, the biggest fear is the organised force of the working class of the country. By relegating the labour laws of the country into four codes, the real intent is to make the workers powerless in front of intensive exploitation. Needless to say that the most culpable section of rising unemployment, price rise, hunger andpoor health is the working class of any country. The above figures are shameful enough for any sane citizen of the country, but not so for our rulers.

The field workers, as part of the working class of India are also bearing the brunt of the effort of the current government to steamroll the rights of the workers. The attempt to repeal SPE Act, 1976, introducing Fixed Term Employment, dilution of the Contract Labour and Regulation Act, and trying to increase the working hours from 8 to 12 hours are all signals enough for the employers of the pharma industry to launch scathing attacks on the SalesPromotion Employees of the country. Added to this, the absence of statutory working rules has allowed the employers to alter and complicate the working of the field workers through mindless digital drives. The real work of the SPEs has been obfuscated through superfluous IT related works that hardly have any relation to actual Sales Promotion.

The organised councils are facing the most intense form of attacks from their employers at present. The recognised bilateral forum for settling grievances are denied, leaderships and activists of the union are attacked and terminated, wages are cut, established working conditions are changed at the whims of the employers. Individual councils are fighting courageously against these attacks, but in the present scheme of things that may not be sufficient to stymie the intensity of attacks. Throughout the country, members of FMRAI participated in Anti Victimisation Day to indicate their no holds barred attitude to fight against the onslaught of the pharma employers in India. The point is to heighten the movement, to send loud and clear message to the pharma industry and the central government that here is a federation of field workers who are not prepared to accept the attacks hands down. Therefore it is now incumbent for all of us to march to the national capital, as per the call of FMRAL on November 21st. 2022. Onward to Delhi, to resistto fight back and protect our rights, in this 75th anniversary of our independence!

Media focuses FMRAI

Huge uproar was observed in all the leading print and electronic media on the PIL filed by FMRAI in Supreme Court for statutory codification of UCPMP and demand on reduction of medicine prices. Renowned media houses interviewed the leadership of FMRAI during this period. Press Release issued by FMRAI.

There have been various reports published in the press and electronic media in relation to the proceedings in the Supreme Court yesterday on the UCPMP case creating confusion. In this connection the following are the positions. Our factual organization FMRAI is no way connected to such mal propaganda by the press to create hyper sensation. FMRAI made a petition to the Supreme Court for making the Uniform Pharmaceutical Code of Marketing Practices (UCPMP) statutory with stringent punishment clauses on violation, pharmaceutical the companies are not abiding to the directives voluntarily as it exists at present. The Apex Court directed the Central government to give their submission within a stipulated time frame. The

government is evading to make their submission and delaying the case. In the intervening period in reply to a question in Parliament the minister made statement that no violation is reported by civil society on the issue and our federation has filed a case in the Supreme Court which is pending. In the last hearing date the union government again did not give their submission, at that point of time our lawyer submitted the CDBT report regarding one company categorically stating that it is the observation of a government agency as published in the media and not our statement. He also submitted the statement of the minister in the parliament to expose the contradictory role of the Central Government. On one hand stating that the issue is in Supreme Court and on the other not submitting their reply to our petition in the court and cause delay.

Surprisingly the media is making their own stories and putting it as our statement without even verifying the facts to dilute the issue and turn the direction to a specific brand of a company instead of exposing the pharmaceutical industry practice of PAY FOR PRESCRIPTION, which is designed by the larger section of employers in pharma sector to register quick sales and maximize profits. Some of these media are also trying to tarnish the image of the doctor fraternity unnecessarily without exposing the root cause of such unethical practices. Our submission is that the government must frame laws to stop unethical practices in pharma marketing and reduce prices of essential medicines through price control which will benefit the common people of the

Jatha on medicine related demands



In pursuance of long pending demands forZero GST on Medicines and Medical Devices; allocation of 5% of GDP to healthcare; To prevent the takeover of Indian companies by multinationals; Torevive the public sector drug units including vaccine producing unit; To impose price control on all essential medicines; To revert to cost based system and reverse the present market based pricing system and To stop online sales of medicines, members of BSSR

implemented programmes on medicine related issues at Patna and Ranchi on 22nd August 2022. In this background all 34 Units of BSSR Union organised Special Unit meetings where the demands have been explained. 34 Units conducted street corner meetings, organized jatha and collected signatures from the toiling masses in different parts of the districts. Members of the units submitted the memorandum to the Hon'ble Prime Minister through district administration. On 22nd

August 2022 Jatha culminated at Patna and Ranchi. Bihar based members from different units of BSSR Union attended jatha which commenced from Patna Junction and culminated at District Magistrate Office of Patna. During the jatha rally administration attempted to stop the rally and jatha but could not succeed. Jatha culminated at Gandhi Maidan, Patna.Street corner meeting washeld which was addressed by Shashi Prakash, General Secretary, BSSR Union and Devashis Roy, Vice

President, FMRAI. A memorandum was submitted before the Hon'ble Prime Minister along with 20,000 signatures signed by toiling masses of different places of Bihar.
