### 26th Conference of FMRAI at Kota

#### Fighting the Most Powerful Exploitative System in History of Mankind

26<sup>th</sup> Conference of FMRAI was held at Kota (Rajasthan) on 10<sup>th</sup>, 11<sup>th</sup> and 12<sup>th</sup> March 2022. Last FMRAI Conference was held in Patna (Bihar) in February 2019. The Kota Conference was held in NI Joseph Nagar (former President of FMRAI), Apurba Ghosh and NK Tarafdar Manch (both former Treasurers of FMRAI). Two gates were in the name of Manohar Parchure (First General Secretary of FMRAI) and RP Singh (former Vice President of FMRAI). Four columns were erected near the Martyrs Column in the name of Saleem Patel, Kalyan Bose, SK Talukdar and NP Saini (all former Working Committee Members of FMRAI). The Conference started with flag hoisting by FMRAI President Comrade Ramesh Sundar. Floral tributes were paid to martyrs. 555 delegates including 10 women delegates attended the Conference.

सम्मेलन का उद्घाटन कॉमरेड ज्ञान शंकर मजूमदार, राष्ट्रीय उपाध्यक्ष, सीटू ने किया. उन्होंने बताया कि FMRAI की जड़ें देश के स्वधीनता आंदोलन से जुड़ी हैं. देश के स्वतंत्रता सेनानियों में से कइयों ने आजादी के बाद दवा प्रतिनिधियों की यूनियन की शुरुआत की. उन्होंने कहा कि 28 और 29 मार्च 2022 को होने वाली आम हड़ताल, चार श्रम संहिताओं को खत्म करने की

दिशा में एक बड़ा कदम होगा. इस दिन संयुक्त किसान मोर्चा ने मजदूरों के समर्थन में देशव्यापी कृषि बंदी का आह्वान किया है.

FMRAI के जनरल सेक्नेटरी कॉमरेड शांतनु चटर्जी ने कहा कि यह सम्मेलन देश के मजदूर आंदोलन को आगे बढ़ाने में एक महत्वपूर्ण भूमिका निभाएगा. सम्मेलन की आयोजन समिति के अध्यक्ष कॉमरेड राकेश गालव और स्वागत समिति के अध्यक्ष कॉमरेड रविंद्र शुक्ला अध्यक्ष, सीटू राजस्थान ने प्रतिनिधियों का स्वागत किया. उन्होंने कहा कि राजनीति के पीछे की नीतियों को समझकर ही मजदूर आंदोलन को सफल किया जा सकता है. उद्घाटन सत्र को संबोधित करते हुए श्री मुकेश गालव, जॉइंट जनरल सेक्रेटरी, आल इंडिया रेलवे मेन्स फेडरेशन (AIRF), महामंत्री हिंद मजदूर सभा राजस्थान ने कहा कि रेलवे, कोयला, बैंकिंग, बीमा, रक्षा क्षेत्र तथा अन्य क्षेत्रों के मजदूर अपने उद्योग को बचाने के लिए संघर्ष कर रहे हैं. आई एम ए, किसान सभा, जनवादी महिला समिति, जनवादी लेखक संघ, एस एफ आई तथा अन्य जन संगठनों ने FMRAI के सभी आंदोलनों के समर्थन का आश्वासन दिया.

जनरल सेक्रेटरी रिपोर्ट का समर्थन करते हुए सभी वक्ताओं ने कहा कि देश की आर्थिक संप्रभुता की रक्षा के लिए मजदूर वर्ग को किसानों के साथ एकता बनाकर संघर्ष करना होगा. इन संघर्षों को कुचलने के लिये केंद्र सरकार और कई राज्य सरकारें लोकतांत्रिक अधिकारों पर बेरहमी से हमला कर रही हैं. मजदूरों का संघर्ष देश के संविधान को और देश की एकता को बचाने का संघर्ष है. FMRAI के सभी सदस्य अपने संगठन और संघर्ष को मजबूत करके इस महान संघर्ष में अग्रणी भूमिका निभाएंगे.



# **FMRAI Conference: Vision 2025**

#### The Truth, the Whole Truth, and Nothing but the Truth

Presidential Address. FMRAI General Secretary Comrade Santanu Chatterjee placed General Secretary Report. FMRAI Treasurer Comrade Partha Rakshit placed Treasurer Report. Both the Reports were passed unanimously after discussions and clarifications. The service and working conditions of the SPEs have deteriorated due to the Government's policies and the attacks of the managements. 26th FMRAI Conference discussed "Vision Document 2025" and suggested planned, focused and concentrated approach in countering the challenges.

**There is** 1) Increased attacks on the workers' rights by employers. 2) De-unionization, appointment of SPEs in officer categories. 3) Sales related victimisations. 4) Imposing Work-from-home promotional activities. 5) Mindless digiltalisation, surveillance, tracking, data collection, etc. 6) Delay in legal process. 7) Weakness in Council Networking. 8) Mobilisation in Council subcommittee and increased functioning. 9) Lack of members' participation in agitation programs.

The Vision Document suggests 1) Consolidation of fieldworkers in Councils. 2) Increase number of All India Councils. 3) Strengthen Council Sub Committees at all levels. 4) Unified programme of Councils against attacks on rights and digitalization. 5) All India programme at Mumbai.

Demands of SPEs working in small scale sector or employed in commission and contract basis. 1) Regularisation of jobs. 2)

FMRAI President Comrade Ramesh Sundar delivered the Implementation of labour laws. 3) Fixation of minimum wages of Rs. 26,000 per month. 4) Timely payment of salary and expenses reimbursements. 5) Payment of statutory Bonus, Provident Fund, ESI and Gratuity.

> To achieve this 1) Campaign amongst concerned fieldworkers. 2) Unit level separate meetings. 3) Initiate discussion with respective employers. 4) Filing of complaints with labour authorities. 5) Plan for agitation programmes at sub-unit and State level.

> Organisational approach should be 1) Streamlined Functioning at All India, State and sub-unit level. 2) Focus on lively contact with members. 3) Reach the unreached. 4) 125,000 membership by next FMRAI Conference in 2025.

> For notification of Statutory Working Rules, Tripartite Meetings, **Enactment of UCPMP and Right to Privacy the Vision Document** suggested Movement in 2022 as 1) Uniform implementation of Programs at sub-unit level. 2) State-level or Zonal level rallies. 3) All India programme at New Delhi.

> The Vision Document provides a direction to 1) Improve social consciousness. 2) Raise ideological convictions. 3) Concretise our approach to confront all challenges. 4) Break the barriers in the advancement of organisation and movements. 5) Consolidate the organisation in both quantitative and qualitative terms. 6) Help in planning strong, militant movements in 2022, 2023 & 2024.

> The Vision Document will be further updated based on discussion in the Conference.











Resolutions adopted in FMRAI Conference: 1) All India General Strike 2) Statutory Working Rules 3) Against Growing attacks on Jobs of the SPEs 4) Against Communalism and attack on Democracy 5) Medicine Related Demands 6) Against Price Rise.

FMRAI and Pfizer management signed 5<sup>th</sup> successive Wage Settlement on 28/02/2022. The settlement is effective for a period of three years from 01/01/2022 to 31/12/2024.

On the day of settlement, it covered 84 confirmed **Sales Promotion Employees.** 

The average benefit is Rs. 8500 per month in salary part. 65% is in Wage part and 35% is in non-Wage part. Apart from this there is increase in daily allowances and travel fare.

This settlement has further strengthened the bilateral relations.

#### Settlement Signed in Union Drug Company by FMRAI



Successful Settlement was signed on 24/03/2022 between Union Drug Management and FMRAI to increase daily allowances and travel fare. There is upward revision in H.Q., Ex-Town, Out Station and Metro City Daily Allowances. The Travel Fares are also increased. This settlement was pending for last two years. Management agreed to pay the arrears.

# All India General Strike on 28 & 29/03/

### वे डरते हैं कि एक दिन निहत्थे और ग़रीब लोग उनसे डरना बंद कर देंगे

UPMSRA members participated in two days all India General Strike on 28th and 29th March 2022. This General Strike was called by the Joint Platform of the Central Trade Unions and Independent All India Federations (including FMRAI) against the anti-worker, anti-farmer and anti-people policies of the central government.

The call of General Strike came in continuity and as follow-up of the ongoing struggle of the two main producing classes to halt the destructive anti-national policy regime of the most barbarous authoritarian force in governance putting the country's economy into auction mode in favour of the handful big corporates, both foreign and domestic. This is state-sponsored pilferage of the country's exchequer and people's assets; and, in the process, heaping unimaginable miseries, destitution and distress on the majority of the working populace putting even their human survival at stake.

This was 21st countrywide General Strike against the retrograde neoliberal policy regime since its official advent in 1991. This Strike was supported by the Samyukta Kisan Morcha (SKM), the biggest ever farmers platform in Independent India.

**Ballia** 

This General Strike was different from earlier workers General Strike against neo-liberal policies since 1991. This strike was in continuation of the ongoing joint struggle of the two broadest national platforms of the workers and farmers, since 26th November 2020 Action Day, mainly against three retrograde Farm Laws; four anti-labour Labour Codes; massive privatisation drive including PSUs, government departments, like defence and health, and public sector and governmental infrastructures through NMP; and for other major demands of the people.

The yearlong struggle of the farmers, with solidarity actions of the workers, achieved a major victory when Modi government was compelled to repeal the three Farm Laws. The workers strike has the support of SKM who gave call of Rural Bandh on Strike days by the farmers in solidarity with the workers. Facing the protest since 26<sup>th</sup> November 2020, the Modi government also kept on hold the implementation of the four Labour Codes.

In such a situation, it is necessary for the Trade Unions to continue the strike-struggle till the Labour Codes are repealed and, till then, to force Modi government to keep on hold their implementation.

#### FMRAI Denounces Reduction in Interest on EPF from 8.5% to 8.1%

In another anti-worker move, the government has reduced the interest rate on Employees Provident Fund (EPF) from 8.5% to 8.1% for year 2021-22. The reduced interest rate is lowest in last 44 years. FMRAI has written letter to Minister of Labour and Employment Shri Bhupendra Yadav denouncing the government decision and demanding restoration of 8.5% interest on EPF.
